We hereby inform you that Akvárium Klub Üzemeltető Korlátolt Felelősségű Társaság (registered offices: 1051 Budapest, Erzsébet tér 12. company registration number: 01-09-182559, e-mail address: [info@akvariumklub.hu](mailto:info@akvariumklub.hu)), as the data processor and operator, Akvárium Gasztró Vendéglátó Korlátolt Felelősségű Társaság (registered offices: 1051 Budapest, Erzsébet tér 12. company registration number: 01-09-275978, e-mail address: [info@akvariumklub.hu](mailto:info@akvariumklub.hu)), Akvárium TV Korlátolt Felelősségű Társaság (registered offices: 1051 Budapest, Erzsébet tér 12. company registration number: 01-09-203515, e-mail address: [info@akvariumklub.hu](mailto:info@akvariumklub.hu)), as data processor (collectively as: Akvárium Klub) utilizes an electronic surveillance system within the premises designated by the present sign for the protection of human lives, physical integrity and the protection of property, which allows for the recording and storage of imagery.

We hereby inform you that the information in question is presented through the present material as well as through the text and/or icons used in the various areas under surveillance and through the camera regulation included in the data processing policy.

The legal basis of the data processing consists of the legitimate interests of Akvárium Klub, which you have expressly acknowledged by entering the premises. Accordingly, when you enter and reside in the premises in knowledge of the present information, based on our legitimate interests you acknowledge cameras may record images of you. The surveillance cameras are operated 24 hours a day, seven days a week, recording data directly.

Place of storage of the recording: 1051 Budapest, Erzsébet tér 12.

Duration of storage: Pursuant to Section 3. 2. of Act CXXXIII of 2005 (in lack of usage, for three workdays after the creation of the recording)

Entitled persons to be apprised of the information: chief executive officer

Manner of data processing: electronically, automatically.

Source of data: directly from the concerned party.

Data transmission: data is only transmitted to third parties under cases stipulated by law.

Organizational and technical measures to ensure the protection of data: see the camera regulation for details.

Automated processing, profiling: such data processing does not take place.

You may request further information, deletion or restriction of the data processing or object to the processing of personal data and may exercise rights pursuant to other legislation, if any, in writing through the above-listed contact information of the data processor, or may turn to a court of law due to the violation of rights, demand compensation and recompense as well as turn to the Hungarian National Authority for Data Protection and Freedom of Information ([www.naih.hu](http://www.naih.hu)).
