HOUSE RULES

The following House Rules of **Akvárium Klub** operated by **Akvárium Klub Üzemeltető Korlátolt Felelősségű Társaság** (1051 Budapest, Erzsébet tér 12., Company registraDon number: 01-09-182559, Telephone No.: +36 30 860-33-68, e-mail: info@akvariumklub.hu, hereinaPer as: the Operator) set forth the mandatory rules of entry and general rules of conduct pertaining to Akvárium Klub. Upon entering the premises of Akvárium Klub, Visitors acknowledge these House Rules and that compliance with the House Rules shall be inspected by the Operator for the purpose of ensuring the safety and security of Visitors as well as for upholding the Operator's legiDmate interests.

I. RULES OF ENTERING AKVÁRIUM KLUB

- 1. / Visitors may enter Akvárium Klub during opening hours. The Operator may charge a fee for parDcular events of Akvárium Klub. Such fees may be determined by the Operator, at its sole discreDon. Entrance fees are listed on the www.akvariumklub.hu website and at the on-site Dcket office. The Operator precludes the possibility of exchanging, replacing, re-exchanging Dckets or refunding their purchase price in any other manner, save for the case when the event in quesDon has been cancelled. InformaDon on the opening hours of the on-site Dcket office can be obtained from the Operator's online pla_orms and on-site.
- **2.** / Visitors may only enter and leave the premises of Akvárium Klub through the entrances open for Visitors guarded by the Operator.
- 3. / The purchased Dcket solely enDtles Visitors to the wristband allowing entry to the parDcular event insofar as the Dcket is original, has not been used yet and the person in possession of the Dcket has acquired it lawfully. The Operator expressly reserves the right to request the Dcket holder to present documents or cerDficates providing evidence for the lawfulness of acquiring or purchasing the Dcket in the event it is suspected during entry that Visitors acquired Dckets in an unlawful manner (specifically, but not limited to the case of fraud commiaed with the use of credit card), to determine the adequacy of such documents and to invalidate the Dcket and deny entry in the absence of such documents or cerDficates without being required to refund the purchase price. The Operator is also enDtled to deny entry if the Dcket holder wishes to enter the event with a Dcket that is fake, forged or already used.
- **4.** / The damage to or loss of the wristband shall be the sole responsibility of Visitors, therefore, in such case, Visitors forfeit their rights granted by the intact wristband and must vacate the venue. Damaged wristbands (re-sealed or severed, wristbands with fasteners having been opened, those with a diameter exceeding the diameter of the hand of the Dcket holder or wristbands that have been tampered with in any other manner) are invalid. The Operator will not replace or exchange damaged or lost wristbands. The Operator reserves the right to conDnuously inspect the wristbands of visitors within the premises of Akvárium Klub through on-the-spot checks. The Operator expressly reserves the right to deny entry in cases where it is suspected that the wristband is not original, fake, forged, re-sealed from a previous event or has been tampered with in any other manner.
- **5.** / For the safety of visitors of Akvárium Klub, the Operator reserves the right to restrict the scope of objects to be taken to the premises of Akvárium Klub (e.g. large bags, umbrellas). Therefore, it is expressly prohibited to take drugs, pyrotechnic devices, objects or devices containing explosive, toxic or flammable substances, tools suitable for making graffiD, airbrush sprays, felt-Dp pens, fire arms, knives, buaerfly knives, switchblade knives, gas sprays or blackjacks, batons, metal chains, throwing

stars, slingshots and any other objects of special concern to public security as specified in laws on tools especially dangerous to public security in effect from Dme to Dme (currently in Government Decree No. 175/2003. (X. 28)) and generally to take objects that are illegal to possess, or which may otherwise pose a danger to the safety of persons residing in Akvárium Klub. Visitors may not enter the premises of Akvárium Klub with an object subject to restricDon.

For the events, Akvárium Klub shall operate a cloakroom, the use of which is obligatory. Visitors may not enter specific areas of Akvárium Klub (Large Hall, Small Hall, Akvárium Lokál) with coats, bags and umbrellas, which they are required to deposit in the cloakroom. The Operator charges a fee for the use of the cloakroom, which is currently HUF 400 per coat or other possessions that must be deposited (bags, umbrellas, etc.). For more information on the usage of the cloakroom and the range of items that can be deposited there, please contact the Operator at the info@akvariumklub.hu email address.

- **6.** / Visitors may not take any beverages or food inside the premises of Akvárium Klub that are not distributed by the Operator on the premises of Akvárium Klub.
- 7. / Visitors may not enter the premises of Akvárium Klub in an intoxicated state or in inappropriate clothing. The Operator reserves the right to control access for the safety of other Visitors.
- **8.** / Pursuant to SecDon 26 of Act CXXXIII of 2005 on Security Services and the AcDviDes of Private InvesDgators, the Operator may inspect any baggage, remove certain persons and stop them from entering the premises at the entrance and within the premises of Akvárium Klub. The Operator shall employ the services of a security service provider as specified in Act IV of 1998 on RegulaDons on Security and Private InvesDgaDon Services Provided by Business Enterprises and on the Trade AssociaDon of Security Guards and Private InvesDgators in order to ensure compliance with the House Rules. Upon entering the premises, Visitors expressly agree to fully cooperate with such service providers within the legal framework and to adhere to their instrucDons in the case of an emergency. Should Visitors wish to file a complaint regarding the conduct of such persons, they may do so at the offices of the Operator, possibly by indicaDng the ID number.
- 9. / Other than assistance dogs, guide dogs and police dogs defined in laws, only pets deemed to be harmless according to public opinion that can be carried on a leash and do not pose a risk to the lives, health or physical integrity of Visitors and others may be brought into the open-air premises of Akvárium Klub free of charge and accompanied by their owners, solely during dayDme opening hours (every day from 12.00 noon to 5.00 pm) in compliance with general norms, without disturbing other Visitors. If deemed jusDfiable by the Operator, it may call on Visitors arriving with a pet to use a muzzle and leash or, alternaDvely to vacate the premises of Akvárium Klub. No pets other than the assistance dogs, guide dogs and police dogs defined by law may be brought into the open-air areas and enclosed spaces of Akvárium Klub in the evening hours (from 8.00 pm to closing). / Visitors are prohibited from bringing bicycles to the guest area of Akvárium Klub, including the area of the terrace. Visitors arriving by bicycle may use the public bicycle-racks in the area.
- 10./ In case of non-compliance with the rules prescribed for Visitors outlined in items no 1-9 above, the Visitor may be prevented from entering the premises of Akvárium Klub or may be removed therefrom. The staff may refuse the entry of persons
 - whose behavior, based on the judgment of the security personnel, endangers the life, physical integrity or integrity of other persons or their property;
 - who were previously removed or banned from the premises of Akvárium Klub;
 - who fail to comply with the required security checks;

- who are unable or unwilling to verify their age with their personal ID card, passport, driver's license or other document suitable to verify personal idenDty;
- who incite hatred against members of social groups, or otherwise incites unrest within the audience with their aggressive behavior;
- who fail to remove items from the premises of Akvárium Klub listed under item no. I/5 above, despite being called on to do so;
- who have not entered the premises of Akvárium Klub through the entrance, or who have been removed or banned from the same;
- acDng in a manner posing threat to the natural or built environment, or engaged in vandalism or other forms of conduct that serve as the basis for police acDon;
- **11** Persons who show aggression against Visitors and staff can be removed from the premises of

Akvárium Klub without undue delay.

12./ Persons removed or banned from the premises of Akvárium Klub pursuant to the aforemenDoned may not claim a refund for the entrance fee.

13. / Rules pertaining to Visitors under 18 years of age

Visitors under 7 years of may enter events free of charge accompanied by an adult. Children under 3 years of age may only aaend concerts with earplugs.

Visitors under 16 years of age (those who have not yet turned 16 on the given day) may only enter the events of Akvárium Klub when accompanied by an adult with a valid Dcket or when accompanied by an adult with a valid Dcket authorized by a parents. The parental permission form can be downloaded here.

Visitors over 16 years of age (who are no less than 16 years of age) may enter by purchasing Dckets even when not accompanied by an adult.

Visitors under 18 years of age (who are under 18 years of age) shall receive wristbands of a disDncDve color — the issuing of which requires presenDng documents (idenDty card or passport) that verify Visitors' age. Damaged wristbands are void and the removal of disDnguishing wristbands is prohibited.

Only visitors over 18 years of age may enter events that start aPer 10 pm.

Operator may diverge from the procedures and protocols described above at its own discretion.

II. RULES OF CONDUCT

1. / Visitors shall conduct themselves in a manner complying with general norms, relevant legal regulaDons and these House Rules within the premises of Akvárium Klub. Visitors shall refrain from all expressions, communicaDons or acts that may endanger or harm the personal rights, lives, health or

physical integrity of others. Within the premises of Akvárium Klub, Visitors shall exercise utmost care regarding the protecDon of natural values and shall refrain from harming the same. The Operator requires Visitors to use the waste collecDon bins for the disposal of waste.

2. / Visitors acknowledge that the Operator and any persons and members of the press to whom the Operator granted a permit (pursuant to the provisions of the contracts concluded with them) as well as other Visitors may produce audio or video recordings of any events held at Akvárium Klub. Upon entering or residing in the premises of Akvárium Klub, Visitors may enter the field of view of cameras and thus, may be recorded and broadcasted, which means that video or audio recording may be produced of Visitors which may be subsequently used.

Pursuant to the abovemenDoned, by entering Akvárium Klub and parDcipaDng in any events of the same, Visitors consent to the producDon and broadcasDng of video and audio recordings as well as their use in any other manner and consents to the display of their face, appearance and expressions on the condiDon that Visitors may only be named with their express consent.

Insofar as Visitors qualify as public figures, they may be named without their consent.

The person producing the recordings menDoned above shall acquire a transferrable and exclusive license to the unrestricted use in terms of Dme or place for the recordings of Visitors. The Operator, as well as any person authorized by the same may uDlize, use (including the promoDon of Akvárium Klub), mulDply, publish, adapt, disclose or distribute the recording in relaDon to Visitors without any restricDons. Visitors expressly acknowledge that the Operator and the persons authorized by the same may record the events, concerts and events of Akvárium Klub, may mulDply the recordings, distribute them on image-bearing media, broadcast them or distribute them to the audience otherwise repeatedly, including the case when the event or concert is broadcasted to the audience via cables or other means (e.g. via YouTube) so that the audience may choose the place and date of access at their own discreDon. In such cases, Visitors expressly acknowledge that they are not enDtled to any sort of compensaDon or consideraDon in relaDon to the aforemenDoned publishing of said recordings.

Visitors are enDtled to produce audio or video recordings in the premises of Akvárium Klub on the condiDon that such recordings may only be made with the prior wriaen consent of the Operator. Visitors may not sell or uDlize such recordings for consideraDon or without consideraDon for commercial purposes and may not name Visitors displayed on the same without their consent and may not infringe their personal rights. The Operator expressly precludes any liability for damages arising from Visitors' non- compliance with the aforemenDoned.

- **3.** / Visitors may not pursue any business, commercial or promoDonal acDviDes within the premises of Akvárium Klub without the Operator's prior wriaen consent.
- **4.** / Akvárium Klub will not serve persons under the age of eighteen and intoxicated persons with alcoholic beverages. When being served at the counter, Visitors may be requested to verify their age with a personal ID card. Insofar as Visitors are unable or unwilling to verify their age in the aforemenDoned manner, the Operator may deny serving them alcoholic beverages. Pursuant to the laws in effect, the use of substances qualifying as drugs is prohibited within the premises of Akvárium Klub and shall consDtute a criminal offense.
- **5.** / The Operator, for security and safety purposes, shall use a surveillance system at the entrance of Akvárium Klub, the terrace, in guest areas, bars and in all event halls. The recordings made in this manner shall be deleted within 3 working days, if no circumstances implying criminal offenses or violaDons of laws have been recorded.

- **6.** / The equipment, devices and transport routes of Akvárium KLub shall be used in accordance with their present funcDon and with due care, taking into consideraDon the disDncDve colors, lighDngs and change of pavement. Akvárium Klub assumes no liability for any accidents or injuries arising from any use that is not in accordance with their proper funcDon, or injuries suffered under the influence of alcohol or other substances.
- 7. / With regard to the fact that the purpose of Akvárium Klub is to provide Visitors with civilized and undisturbed entertainment, any kind of demonstraDon, regardless of the number of parDcipants, is prohibited within the premises of Akvárium Klub.
- 8. / Pursuant to Sec]on 2 (1) of Act XLII of 1999 (on the Protec]on of Non-Smokers and Certain Regula]ons on the Consump]on and. Distribu]on of Tobacco Products), smoking is prohibited in the closed spaces of Akvárium Klub. The Operator shall designate a smoking area on the terrace, five meters from the entrances. The prohibiDon of smoking shall extend to all smoking and/or subsDtute smoking devices including vapor smoking devices. In the case of the non-observance of the rules on smoking, the Visitor may be prevented from entering the Akvárium Club area or may be removed therefrom.

III. MISCELLANEOUS PROVISIONS

1. / The Operator shall only be held liable for violaDons caused intenDonally within its own control, or posing threat to human life, physical integrity or health. The Operator precludes liability for any damages other than those in relaDon to the statutory rights of Visitors.

High-performance lighDng and sound are equipment are installed within the premises of Akvárium Klub and Visitors shall solely enter the premises at their own risk. Akvárium Klub operates its lighDng and sound equipment in a verifiable manner, in accordance with the relevant health regulaDons and noise protecDon regulaDons. Akvárium Klub shall not be responsible for the health complaints of Visitors, which are assumed to be related to the improper operaDon of the equipment. It is not recommended for Visitors prone to epilepsy to the events; in all cases, please consult a physician.

When purchasing a Dcket online, Visitors with reduced mobility and/or a wheelchair will receive a cerDficate (voucher) by choosing the appropriate opDon, which enDtles them to enter and reside in the accessible auditorium areas upon presenDng said voucher at the venue. Due to the nature of the venue, this opDon is only available at select events, in limited numbers. Insofar as addiDonal seats remain based on the number of pre-cerDfied persons, the use of the accessible auditorium areas can also be provided for guests with reduced mobility and/or wheelchairs who have not registered in advance.

- 2. / Visitors acknowledge that the Operator may not be held liable for any damage or abuse arising during or as a result of the applicaDon of either payment method, and, therefore, shall not be held liable if they fail to report the loss of their credit card to the bank issuing the card. The Operator shall not be held liable for the defects, deficiencies or safety of the applied payment method.
- **3.** / Visitors shall be fully liable, both in terms of civil and criminal law, for any damages caused within the premises of Akvárium Klub by themselves or by any of their pets against the Operator, other Visitors or any third parDes. The person responsible for the damage shall not be exempt from liability by referencing the Operator's security staff's failure to prevent or miDgate damage.

- 4. / The Operator operates a cloakroom within the premises of Akvárium Klub. The cloakroom Dcket only enDtles Visitors to place their belongings once. The belongings of Visitors placed in the cloakroom will only be returned in exchange for the cloakroom Dcket. In the case of losing the cloakroom Dcket, the Operator shall only return the belongings of Visitors upon the closing of the cloakroom. We kindly ask Visitors to take good care of their cloakroom 5ckets as deposited valuables will only be returned in exchange for the 5cket. In the case of lost 5ckets, we charge a remanufacturing feel. Only original cloakroom Dckets enDtle Visitors to claim belongings, Dckets presented via phone are not suitable for this purpose. *Items le? in the cloakroom shall be stored* for a period of 30 days, a?er which they will no longer be kept at the cloakroom. The Operator may only be held liable for any damages caused to the belongings or valuables brought into the club by Visitors or the loss of the same if such belongings have been deposited in the cloakroom. The Operator fully excludes its liability in this regard in all other cases. The Operator only accepts belongings and valuables to be placed in the cloakroom that are usually brought by visitors to insDtuDons similar to the Klub and the value of which does not exceed HUF 25,000. The Operator does not accept jewellery, cash or securiDes to be placed in the cloakroom. By using the cloakroom, Visitors acknowledge that the value of the placed belongings does not exceed the limit specified in the previous sentence. The Operator expressly excludes its liability for any damage caused to the belongings and valuables specified herein, as well as the belongings and valuables leP in the coats and bags. The Operator will retain the objects leP in the cloakroom for a period of no longer than one month. Visitors may make inquiries about their belongings by wriDng an email to info@akvariumklub.hu.
- **5.** / The Operator reserves the right to change the event and iDnerary. Times and dates listed on Dckets and the website are for informaDon purposes only, the duraDon of concerts and subsequent events may vary compared to what was previous announced.
- **6.** / Insofar as a Recup (RePohár) system is operated at an event, Visitors may use said catering service in observance of the related rules. More informaDon on this is available at: https://akvariumklub.hu/gyik/

ReCups can be redeemed for tokens. ReCups cannot be redeemed for cash.

Entering concert halls with glass cups is prohibited. If required, the staff can provide plasDc cups.

- 7. / The Operator reserves the right to charge different amounts for various events and to keep certain venues closed at its discreDon or to restrict access to said areas in relaDon to private events.
- **8.** / The Operators calls on Visitors to promptly noDfy the security staff or the staff of Akvárium Klub should they become aware of any irregulariDes, abandoned packages, accidents or vandalism. In the case of an emergency, please follow the instrucDons of the security staff, stay calm and vacate the premises through the nearest emergency exit.
- **9.**/ The Operator reserves the right to deviate from the contents of the House Rules, where appropriate, and shall inform Visitors of said changes through its various communicaDon channels.

The House Rules of Akvárium Klub shall remain in effect for an indefinite period, which the Operator is enDtled to amend unilaterally. Any amendments shall enter into effect when stated on the website. Visitors who were previously authorized to enter the premises may withdraw without jusDficaDon from establishing a legal relaDonship within 8 days of the House Rules entering into effect, yet no later than within 3 days of the event.
